## Rules & Regulations

- Must be a valid Red Hot Rewards Club member to be eligible - membership is free.
- Must be present to win. The patron whose card is in play at the winning machine must claim the prize.
- The winning patron must remain at their slot machine until the jackpot is verified and paid out.
- Must be 21 years of age and provide one of the following current forms of identification: valid driver's license, government photo ID, military photo ID, passport, state issued ID & NHBP Tribal ID. In the event the photo ID does not have the patron's address the following must be provided for verification: current pay stub, or current utility bill. In the event the patron's ID does not have a picture, but has the patron's current address, the patron must provide one of the following for verification: military photo ID, passport, government photo ID.
- It is the responsibility of each Red Hot Rewards member participating in the promotion to make sure he/she is using his/her authorized card and that the card is working properly. If a card is not working properly, a duplicate card may be obtained free of charge at any Red Hot Rewards booth in the casino.
- On Saturday, June 14<sup>th</sup>, all Red Hot Rewards Club members must have an active wagered session at the time of the cash strike to be eligible.
- Play on Red Hot Credits is not eligible for Red Lightning prizes.
- Bonus play lasting longer than approximately thirty seconds will not be eligible for Red Lightning prizes.
- Following the Red Lightning Cash Blast winner selection, an announcement will be made over the FireKeepers Casino Hotel's casino PA system.
- Entry into promotion gives FireKeepers Casino Hotel consent to use names and likeness of promotion winners for promotional purposes without further compensation.
- In the event of any malfunction or system failure during a promotion, selection will be made by random rewards, a hot seat selection in patron management, until the system is restored. If both systems fail the promotion will be put on hold until one of the two systems are restored. Any prizes that were missed will be awarded upon one of the system being restored or at a later date determined by Firekeepers Casino Hotel staff.
- Each winner is responsible for paying any and all taxes on any prizes won and must authorize the deduction of taxes if any.
- FireKeepers Casino Hotel reserves the right to deny participants, change, modify or cancel the promotion without notice.

- FireKeepers Casino Hotel licensed employees are not eligible.
- If a FireKeepers Casino Hotel employee is selected and identified, they will not be allowed to accept the prize.
- If a prize goes unclaimed, another winner will be selected through Hot Seat drawings at Management's discretion.
- NHBP Tribal Council and Gaming Commission members are ineligible to participate in any promotions.
- Any dispute in this promotion must be directed to the Vice President of Marketing. If needed the NHBP gaming commission will become involved for a resolution process.
